


# Fact sheet Coronavirus (COVID-19)



## COVID-19 impact on Queensland agriculture workforce

COVID-19 may impact your ability to source harvesting and production workers. While there may still be numerous overseas workers available, significant disruption to seasonal worker numbers could occur in various regions.

- **Will my workforce be impacted by the COVID-19 outbreak?**
  - Yes, anticipate and plan for significant reductions across all levels of your workforce.
  - Worker availability issues may arise in:
    - working holidaymakers (i.e. backpackers)
    - overseas student workers
    - seasonal worker programme
    - pacific labour mobility scheme
    - local seasonal workers
    - core permanent ongoing staff
    - other business along the supply chain.
  
- **Where can I source workers from if my normal channels don't work?**
  - **Consider the options** - many businesses have relied on a regular pattern of seasonal workers and a stable, permanent workforce for many seasons. You may not have considered or be aware of alternate ways of recruiting.
  
  - Current options for recruiting workers include:
    - Use the Harvest Trail online facility at <https://jobsearch.gov.au/harvest>—this is a free service
    - Lodge vacancies directly onto [jobsearch.gov.au](https://jobsearch.gov.au), or you can register your business on the Jobactive website to post your positions for free <https://jobsearch.gov.au/employers/registration?workflowId=490f074b-e958-4cb9-82a0-cd50800bb2c1>
    - Contact your local jobactive providers - also at [jobsearch.gov.au](https://jobsearch.gov.au)
    - Use social media (e.g. Facebook, Twitter) and traditional local advertising (e.g. newspapers/community bulletin boards/roadside signs)
    - Contact a licensed Labour Hire service provider. A register of licenced providers at <https://www.labourhire.qld.gov.au/>
    - Encourage your industry representative body/organisation to promote the need for workers (e.g. 'Pick Local' campaign)
      - Consider the Seasonal Worker Programme (Subject to the lifting of current travel restrictions) <https://www.employment.gov.au/seasonal-worker-programme>
      - Consider the Pacific Labour Mobility Scheme (Subject to the lifting of current travel restrictions) <https://www.dfat.gov.au/geo/pacific/engagement/pacific-labour-mobility/Pages/default>.
  
- **How can I guarantee available workers are suitable for my business?**

- Ensure induction processes, role descriptions and work procedures are in place and current (including procedures to mitigate spreading of COVID-19)
- Ensure suppliers of labour (e.g. Labour Hire, Jobactives) understand your requirements and are selective in who they send to you – e.g. heavy lifting, intermittent work hours
- **What is the government doing?**
  - **Government and industry are working together** and meeting regularly to identify current and emerging issues resulting from actions to reduce the spread of COVID-19 throughout the community and developing strategies aimed at addressing these.
  - The Queensland Government already has several agriculture workforce officers in place across Queensland (Queensland Agriculture Workforce Network – QAWN).
    - These officers can provide advice on workforce services and initiatives to all Queensland agribusinesses, regardless of commodity or organisation membership - this is a free service
